**Personal: Articles are washed, dried, sorted by item and folded neatly.

***Special Handling: Articles are washed, dried, sorted by name or identification number, and folded neatly.

**** Healthcare Laundry: All laundry sent from healthcare & acute care facilities. Articles are washed, dried, sorted by name or identification number, and folded neatly. Carts will be returned lined with a plastic bag to meet SB 2679. Includes infectious linens sent properly bagged (water soluble bags placed inside of yellow bags).

\$200 hazardous material fee:

- 1. CALPIA should <u>NEVER</u> receive red Biohazard bags. The customer breaking this protocol will be charged \$200 for proper handling and storage of biohazard "red" bags until the customer who sent them can arrange pickup by their contracted service provider for hazardous materials. If the items are not picked up in a reasonable time period and in the proper manner the customer may experience delays in their laundry services and/ or a daily fee of an additional \$200/ day fee.
- 2. CALPIA does accept contaminated linens if they are properly bagged in a sealed water-soluble bag inside of a sealed yellow bag to protect our workers. Improperly bagged contaminated linens will be processed according to CALPIA procedure and returned to the customer clean. The customer will be charged \$200/load. Contaminated linens are laundry which has been soiled with blood or other potentially infectious materials (OPIM). OPIM means: (1) The following human body fluids: semen, vaginal secretions, cerebrospinal fluid, synovial fluid, pleural fluid, pericardial fluid, peritoreal fluid, amniotic fluid, saliva in dental procedures, any body fluids; (2) Any unfixed tissue or organ (other than intact skin) from a human (living or dead); and (3) HIV-containing cell or tissue cultures, organ cultures, and HIV- or HBV-containing culture medium or other solutions; and blood, organs, or other tissues from experimental animals infected with HIV or HBV. Linens with bugs/insects/mites/etc. should also be treated as contaminated linens.

Note: Sorting of non-laundry items mixed in carts such as shoes/boots, excessive trash, etc. may also result in a Misc. Service charge per pound.
